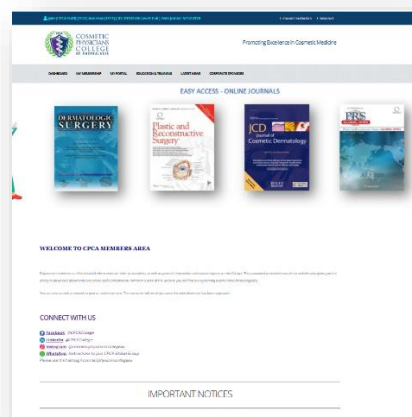
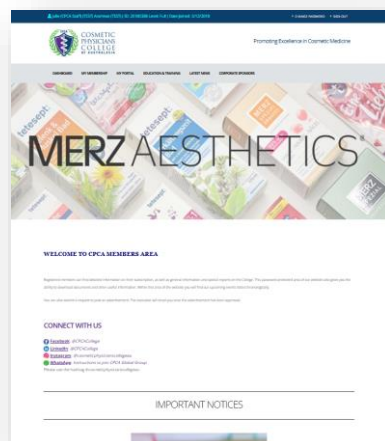

5. Brand & Product Placement – workshops and examinations

Annually, the College provides a hands-on workshop to its members and would welcome our corporate members sponsorship through the provision of product or device demonstrations, lecturers and trainers, etc. ([see 2024 workshop for example](#))

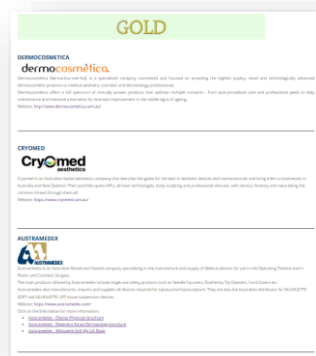

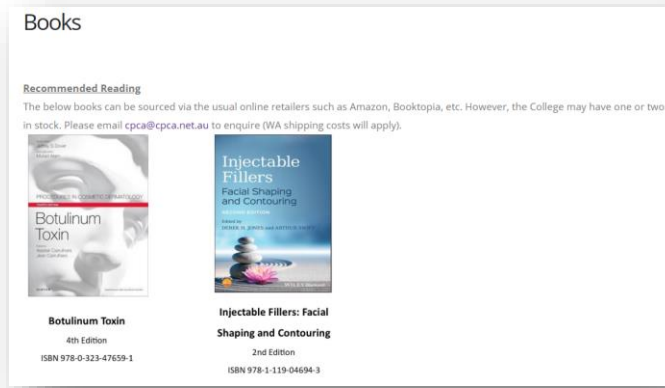

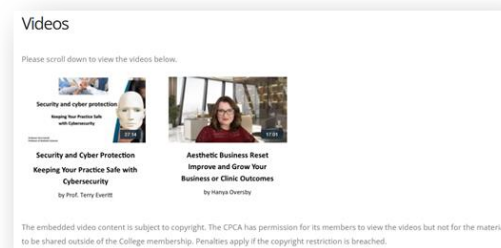
